THE SALE OF THIS AKC PUREBRED SHIH TZU/PUPPY/DOG IS BASED ON
THE FOLLOWING TERMS AND CONDITONS

- 1) The purchase price of puppy/dog is \$_____ with full/limited registration as defined by AKC (American Kennel Club) Shipping is \$_____ Total due is \$_____ minus \$_____ (Deposit) Monies are NON REFUNDABLE. Contract will be terminated and all monies forfeited if not received by the seller at time puppy is 8 weeks of age. Registration fees are the sole responsibility of the buyer. Buyer must take puppy to a licensed vet within 48 hours of purchase or this guarantee is null and void. (this excludes weekends and holidays)
- 2) A 5 year replacement warranty is given for any life threatening congenital condition that causes puppy to expire. A notarized veterinarian statement is required along with all medical documents must be sent to the seller that the puppies death was due to prenatal state or is genetic in nature. Sellers vet must confirm and agree with diagnosis. Seller will then provide buyer with a replacement puppy of equal value and gender from next available litter. No replacement puppy will be given if puppy has not been kept up to date on vaccinations, de-worming, heartworm medication , or is found to have been neglected or has produced offspring.
- 3) The seller assumes no shipping costs associated with sale or replacement warranty.
- 4) To the best of seller's knowledge, this puppy is in good sound health, free of contagious and infectious diseases at the time of sale. No further health guarantee is made. If buyer believes the puppy to be sick, buyer should immediately take the puppy to a veterinarian of buyers choice at their expense. Seller is not responsible for any diseases the puppy would come into contact with once it has left sellers premises. All vet expenses become the sole responsibility of the buyer once puppy has left sellers premises.
- 5) As of date of delivery, this puppy is up to date on all vaccinations and de-worming per age of puppy. Warranty does not cover diseases for which vaccinations could prevent. Warranty also does not cover Hypoglycemia (low blood sugar). This is a very serious condition in small breed

dogs during the transition to a new home. We give you specific instructions in your puppy pac, on how to prevent this from happening. Please follow our instructions.

- 6) This guarantee also does not include Coccidia, Giardia and Kennel Cough. These are bacterial infections and common in young puppies until they have reached an age where their immune systems are stronger. Kennel cough is self limiting and like the common cold must run its course. Full recovery is expected and on its own is not life-threatening. We do give all our puppies the intranasal bordetella vaccine as a preventive measure for this. We treat all our puppies while in our care as a preventative measure for all the conditions mentioned above, but until their immune systems have fully developed, they can be infected and re-infected. Once they are thru puppyhood, you normally are home free. This guarantee also does not cover under-bites as this is considered normal in the Shih Tzu breed .Hernias must be certified by a licensed veterinarian to be life threatening and to have rendered the puppy unfit for purchase in order for surgical repair reimbursement. Pinched nostrils (stenotic nares) are also not covered as this can occur when puppies are teething.
- 7) The size and color of a puppy will mature to is only an estimate based on sellers experience and knowledge of past breeding, study of pedigrees, etc. No guarantee is made as to adult color and size.
- 8) If puppy is sold with full AKC registration(breeding , showing rights) seller cannot guarantee the fertility of a male or female puppy and is impossible to guarantee breeding or show success. It is the sole responsibility of the buyer for bills incurred from breeding or showing said dog. AKC papers will be released for puppies purchased as pet companions upon proof of spay or neuter received by seller from buyers veterinarian.
- 9) Warranty applies to original buyer only and is non transferable if puppy is sold.
- 10) Seller reserves the right of first refusal should buyer choose to place puppy. We do not want any of our puppies to end up in a shelter.
- 11) Buyer agrees that no charge backs will be filed thru credit card companies or paypal transaction for any reason. Should a situation occur buyer would work directly with seller to resolve any conflicts
- 12) Seller assumes no responsibility for medical expenses, mortality, landlord disapproval, allergies or any other undesirable circumstances, once the puppy/dog leaves sellers premises.
- 13) Any disputes will be handled in Ripley County, state of Indiana, at buyers expense.
